

Terms and Conditions of the Competition

1. This Competition is open to customers of Independent participating Optician's ("the Optician") who purchase one pair of Essilor Crizal Lenses and/or one pair of Essilor Optifog lenses (collectively called "the Essilor Lenses").

Consumers of one pair of Crizal Lenses will gain one entry to the Competition and consumers of one pair of Optifog Lenses will gain two entries to the Competition.

There is no limit on the amount of Essilor Lenses that can be purchased by any one consumer.

Entry to the Competition is to be made through the website www.essilor.ie

The Participant will need to answer the Competition Question as provided and compile a Slogan not more than ten words to describe the benefits of Crizal Lenses.
